The MBRF was established in 1999 by Mrs. Evelyn F. McKnight as legacy to her husband William L. McKnight to support research in age related cognitive decline and memory loss as differentiated from Alzheimer's Disease and other dementias or neurodegenerative diseases

The Board of Trustees was originally composed of three founding Trustees but over the years five additional trustees have been added for a total now of eight Trustees, plus the Chair Emeritus and the Corporate Trustee.

The Term of each Trustee is three years but can serve for a total of three terms with satisfactory performance and reappointment by the Board. At the present time, the terms of two trustees have just expired for which we are seeking nominees of qualified individuals for consideration.

Hi Lee,

I wanted to let you know that I did receive your fax earlier today (thanks!) and have been through that material and the website. The MBRF appears to be an incredible organization doing incredible work, and I am honored and humbled to even be considered to fill a position on the Board of Trustees. With that said, before making my decision about letting the nomination move forward, I was wondering if you could answer a few questions:

- 1) If accepted onto the Board, when would my term start (helps me plan my schedule)? It would depend uponwhen your election occurred. It would likely start at the beginning of the next quarter following your election.
- 2) You mention that the term is 3 years, but a Trustee can serve for a total of 3 terms with satisfactory performance. How is performance measured? I guess put another way, what are the expectations the Board will have of me and what strategic initiatives will be met by having me on the board? A list of duties and responsibilities has been developed for trustees. Each trustee signs the form and each year each trustee completes a self-evaluation form which is reviewed by the membership and governance committee and recommends reappointment at the end of each three year period. I've attached a copy of the duties and responsibilities as well as the self-evaluation form.
- 3) You also mentioned that a main objective would be to enlist primary care providers as partners in advancing education and health care initiatives. Is there a communications team? Are the primary care trustees expected to do lectures at state and national meetings to enhance this knowledge or is the role more advisory in nature? Yes, there is communications committee and as education committee as well as a finance committee, research committee, and membership and governance.. The trustees serve in an advisory role and have not been expected to be "road warriors" giving talks and lectures to targeted audiences.
- 4) Finally, you mentioned that the corporate headquarters are in Orlando. How large is the corporation (outside of the 4 research institutions)? The four McKnight Brain Institutes are not a formal part of the corporation. The McKnight Brain Research Foundation does not occupy bricks and mortar space. It is headquartered by the SunTrust Bank which also serves as the corporate trustee. The executive director (formerly with the Foundation for the National Institutes of Health) is a part time employee and lives in Alexandria, VA

Dear Reviewer,

I am a geriatric physician who has been in practice for the past 27 years. I grew up in Seattle, completing elementary school through medical school there. Following Medical School, I did my residency in Internal Medicine at the University of Iowa Hospitals and Clinics. I returned to the University of Washington for a 2-year fellowship in Geriatrics.

I was then recruited to the University of South Carolina where I worked my way up from clinical instructor to full-professor. My last academic position was as Professor and Chief of Geriatrics at the University of South Carolina and Prisma Health. In the course of my academic career, I founded and developed the Senior Primary Care Practice, which at one time, was one of the largest geriatric practices in the Southeast. I assisted in the development of both the Geriatric Medicine and Geriatric Psychiatry fellowship programs. Then, with assistance from nursing and other leadership, we developed an Acute Care for the Elderly (ACE) unit at our main teaching hospital, with a donation of \$500,000 from one of my patients. I have always enjoyed program development and starting programs to enhance the care of older adults.

My research experience has included projects in Alzheimer's Disease, hypertension, osteoporosis, older drivers' assessment and fall detection in older adults. I have coordinated projects with the Fraunhofer Institute for Experimental Software Engineering in Kaiserslautern, Germany, as well as projects with Charite' University Hospital in Berlin. In 2005, I authored, promoted and helped achieve passage of the first in the nation geriatric loan forgiveness program for geriatric physicians practicing in South Carolina. This program is still operational and has been funded continuously since inception. I have been involved as PI, co-PI and co-investigator in over \$6 million in grants from NIH, Donald W. Reynold Foundation, The Hartford Foundation, The Duke Foundation, HRSA, Alzheimer's Association and other funding programs. I am still participating in an NIH R-01 funded falls detection project which I initiated 10 years ago with a grant from the Alzheimer's Association. Additionally, I was the editor-in-chief for a Geriatric Textbook, published by McGraw-Hill in 2011. Since October of 2019, I elected to go back to my roots and become an independent, private practice physician. I currently work as an independent contractor for the Still Hopes Retirement community in West Columbia, South Carolina. This is a continuum of care retirement community that includes independent living, skilled rehabilitation, assisted living and nursing home level of care.

My practice include care for each of these groups of older adults. In the course of my day I will care for independent older adults, who range from healthy to those with multiple chronic conditions as well as long-term care residents and post-acute care older adults who have been recently hospitalized. In addition, every day I am seeing and helping patients and families deal with memory impairment, early memory loss as well as end-stage dementia on hospice. I have the benefit of seeing a wide variety of older adults in almost every condition and living setting imaginable, which I have found to be immensely rewarding. Officers of the Board of Trustees As Approved by the Trustees on July 28, 2021

As stated in the minutes of the October 14, 2014, Board of Trustees meeting, and as relevant to components of discussion during the strategic planning at that time, the Trustees took the following actions regarding the establishment of the Officers of the Board of Trustees:

The Trustees voted to abolish the consensus form of board governance and to establish a Board Chair, Vice Chair and Secretary position (to be held by the Corporate Trustee). On July 28, 2021, the Trustees approved the highlighted additions to this approved policy.

The Trustees agreed upon the following criteria to become an officer of the MBRF:

- 1) Two years of active service as a trustee member are required before becoming an officer
- 2) An individual eligible to serve as an officer may be nominated by another trustee or selfnominate
- 3) The term of office coincides with the fiscal year
- 4) The term of the office of the chair and vice chair is two years. The number of terms is not limited for chair or vice chair.
- 5) The election of the chair and vice chair occur at the spring meeting of the Board of Trustees every odd numbered year (2021, 2023, 2025, etc.) with the term beginning, as stated above, on July 1 and ending on June 30 to coincide with the MBRF's fiscal year.
