Dear Dr. Brady,

The trustees are pleased you have accepted their invitation to serve as a trustee of the McKnight Brain Research Foundation (MBRF). The trustees appreciate your willingness to be considered for a trustee position and believe your service will enhance the work of the Foundation in support of research in age-related cognitive decline and memory loss.

Your appointment as a trustee is effective January 1, 2022, and is for a period of three years. Terms may be renewed, pending approval of the Board of Trustees, for a maximum of nine years.

Under separate cover, Melanie Cianciotto, corporate trustee, will send you the following documents:

- Duties and Responsibilities of a Trustee and the Code of Ethics, along with a commitment form which requires your signature.
- Conflict of Interest policy along with the Conflict of Interest Statement which requires your signature.
- The next Trustees' Meeting will be <u>Wednesday, February 9, 2022</u>. It is currently undecided whether the meeting will be in person or via WebEx. Material for the meeting will be shared with you about a week before.

The compensation for service as a trustee is \$40,000 annually, (\$10,000 payable each quarter) plus reimbursement of out of pocket expenses connected with fulfilling your duties as a trustee. Please confirm with Ms. Cianciotto how you would like to receive your compensation. Ms. Porter will contact you to schedule a phone meeting to share information with you about the MBRF as you begin your tenure.

The trustees are very excited and enthusiastic about your joining as a trustee. We look forward to having you participate in the meeting of the trustees on February 9, as well as looking forward to an enjoyable and enduring relationship.
