MINUTES MCKNIGHT BRAIN RESEARCH FOUNDATION BOARD OF TRUSTEES MEETING October 20, 2011

The Trustee's meeting of the McKnight Brain Research Foundation (MBRF) was called to order at 8:20 a.m. on October 20, 2011 in the Somerset Conference Room at the Hilton Garden Inn Washington, DC/Bethesda.

1. Investment Review

Mr. Hill presented the investment review and commented on key economic and investment factors for the third quarter (Attachment 1).

A. Market Environment

- Investor expectations and confidence declined significantly during the quarter as demonstrated by a substantial spike in volatility and historic low U.S. Treasury yields.
- Large Cap Growth Domestic equities outperformed domestic mid and small cap stocks along with developed international and emerging market stocks during the quarter.
- In light of a downgrade to U.S. Treasury Bonds, the flight to quality move pushed 10-year U.S. Treasury yields below 2% and the 30-year U.S. Treasury yield declined below 3%.
- Hedge fund performance was not able to avoid the increased volatility and flight to quality. Short bias and macro strategies performed best during the period while equity hedge and fundamental value lagged.

B. Manager Performance

 During the quarter, active managers largely struggled versus their respective benchmarks. The Federated Strategic Value fund was an exception as it benefited from investor flight to quality large cap companies paying dividends.

- The PIMCO Total Return Fund experienced a rare period of underperformance. The fund was positioned with a lower exposure to U.S. Treasuries than the benchmark. This along with the subsequent overweight to spread product resulted in a poor quarter for the strategy.
- The Jensen Large cap Growth Fund was sold during the quarter and the assets were transferred to the existing Harbor Capital Fund. The Legg Mason Emerging Markets fund was removed and the assets were moved to a new emerging markets manager utilizing the Oppenheimer Developing Markets strategy.

C. Investment Policy

The trustees amended Appendix A & B of the Investment Policy Statement to include BRDPI at 2.9% and amended the range from 0-10% to 0-20% for permitted fixed income holdings. It was noted by Mr. Hill that the amended range for the fixed income holdings was not considered when the efficient frontier analysis was performed in July 2011. Mr. Hill will monitor the effects of the amended range in preparation for the next cycle for the efficient frontier analysis and review in the summer of 2012. The Investment Policy Statement consistent with the amendments was approved. Mr. Hill and Mr. Raattama were requested to prepare a revised Investment Policy Statement.

Dr. Molly Wagster, Chief, Behavioral & Systems Neuroscience Branch Division of Neuroscience, National Institute on Aging (NIA), met with the trustees and provided comments on her impressions regarding the success of the Foundation in fulfilling its purpose of supporting research in cognitive aging leading the understanding and alleviation of age related memory loss. Additionally, Dr. Wagster highlighted the value of the Research Partnership in Cognitive Aging between the NIA and the MBRF.
