Dear Lee,

My night has bled over into morning! I 'm afraid I was "tuckered out" last night and am sorry I didn't get another note to you.

Actually, my note yesterday ended up containing a lot of the information I have collected thus far. Jon King and I met last week to discuss and feel the Summit could be held in 2017, provided we manage to get agreements in place soon. We both agree that a "mini-symposium" within the Summit that would highlight the progress at the Centers as well as the resources they are building up would be an important component. We were thinking of an overall theme of cognitive resilience and reserve for the Summit. Also, in terms of format, maybe two full days of presentations including the mini-symposium, with an Executive (recommendation) session the morning of the third day. We might consider taking a different approach that we have used in recent years for other large recommendation-generating meetings by assembling writing groups well ahead of the Summit for the purpose of categorizing and organizing content for the Exec session and recommendations. They generally have a series of conference calls prior to the Summit to organize the content. We would hope that the Center Directors and/or selected staff would be key people in these writing groups.

My main concern at this time is that NIA will be supporting a Summit on long term care and caregivers in relation to AD in the fall of 2017 and there is a push to have another general AD Summit in Nov/Dec of 2017. While these would be distinct in time from a Cognitive Aging Summit in April, the sheer number of "Summits" and the work involved seems daunting.

I will be back in touch again as soon as I have another update.

Re: Request for travel and meeting funds for a Workshop for the Brain and Cognitive Health Working Group

Background

At the Tucson McKnight Inter-Institutional meeting, April 27, 2016, a group of 24 scientists from the 4 McKnight Institutions met to discuss potential topics and projects that could lead to grant applications, to outline a path forward, and to document what the group could try to achieve. We first introduced ourselves around the room, and briefly described our interests and research activities. We came to a consensus on 4 topics that we saw potential for fruitful collaborations amongst us. We then had each individual participant "choose one and only one group" to join in a breakout session. Finally, one person from each group reported back to the entire group on the discussions and ideas that arose in the individual groups.

The following are summaries of the topics/projects and issues that were discussed in the 4 break out groups:

Project 1: The role of chronic stress and hypothalamic-pituitary-adrenal (HPA) axis dysregulation in the age-associated decline of executive function and memory.

Project 2: Perirhinal cortex as a biomarker for normative cognitive decline and risk for Alzheimer's disease.

Project 3: Detection of deception in aging: Role of cognition, mood and brain health.

Topic 4: Development of tools to study the above topics, including vascular variables, synaptic imaging methods and monitoring rhythms including sleep.

Summary

At the final 'wrap up' session of the Working Group meeting in Tucson, where all break out groups came back together to present the summaries to the entire group, it became clear that the 4th topic was more 'methodological' than conceptual. Thus, the members of the 4th group have opted to join in one (or more) of the remaining three conceptual Projects listed above as 1-3. In May and June, Jen Bizon, Matt Grilli/Bonnie Levin, and Lee Ryan drafted and passed around versions of short white papers for each topic, with clear aims and goals for the collaborations listed.

The Funding Request

The Brain and Cognitive Health working group requests one more meeting, devoted to furthering the development of these ideas, coordinating the collection of preliminary data for grant submissions, publishable manuscripts of the collaborative experiments,

and more discussion of crafting review articles. We have identified a time at the end of August when many of the original group will have time to attend such a meeting. The consideration of venue was based on flight availability for arrival and departure times, airline ticket or ground transportation costs, and hotel lodging and meal estimates. One Ocean Resort in Jacksonville was the best choice. Estimated costs are listed below based on the number of faculty who have confirmed their availability to date:
